similar conditions.

Department of Disabilities and Special Needs (SCDDSN) plans, develops, oversees, and funds services for South Carolinians with severe, lifelong disabilities of intellectual disability, autism, traumatic brain injury, spinal cord injuries, and conditions related to these disabilities.

Department of Health and Environmental Control – Getting Help for People with Disabilities provides information and resources for people looking for assistance for themselves or a family member with disabilities.

Department of Health and Environmental Control – Help for Brain Injury Patients and Families provides information and resources for people with brain injuries.

Department of Health and Environmental Control (DHEC) promotes and protects the health of the public and the environment in South Carolina.

Family Connection of South Carolina changes lives by making connections, raising awareness, and promoting inclusion for those with disabilities and special healthcare needs.

Get Care South Carolina provides a guide to available resources for older adults, people with disabilities, their family members, and their caregivers in South Carolina.

Head and Spinal Cord Injury (HASCI) Services provides community-based services and supports for individuals with acquired brain injuries, spinal cord injuries, or related disabilities to increase capacity for independent living, community participation, and employment. HASCI Services also provides support groups for brain injury survivors and their families.

Home Again is South Carolina's state Nursing Home Transition Program that helps senior and people with disabilities move from skilled nursing facilities into communities and receive appropriate services and supports.

Individuals Motivating People to Achieve Change Together (I.M.P.A.C.T.) is a state-wide self-advocacy council for South Carolina, and provides information, training, and leadership opportunities to enhance self-advocacy for people with disabilities.

SC Respite Coalition strives expand quality respite opportunities in South Carolina throughout the lifespan for South Carolina families who have a member with special needs.

South Carolina 2-1-1 keeps an accurate and comprehensive database to find health and human services to meet your needs.

South Carolina Assistive Technology Exchange is designed to promote equipment exchange between individuals who need equipment and those who are no longer using their equipment.

South Carolina Client Assistance Program (CAP) advocates, advises, and informs clients, client applicants, and other individuals with disabilities of all the available services and benefits under the Rehabilitation Act.

South Carolina Department of Education – Special Education Services provides information and resources for schools, children with special needs, and their families.

South Carolina Department of Mental Health supports the recovery of people with mental illness through a statewide network of community mental health centers, clinics, hospitals, and nursing homes.

South Carolina Developmental Disabilities Council provides leadership in planning, funding, and implementing initiatives that lead to improved quality of life for people with developmental disabilities and their families.

South Carolina Facility Locator allows users to search for different types of facilities using specific search parameters.

Team Luke Hope for Minds exists to enrich the lives of children impacted by a brain injury and to give hope to their families through support, education, and resources.

The Lowcountry Aging and Disability Resource Center (ADRC) provides assistance and services to eligible seniors and people with disabilities.

The South Carolina Statewide Independent Living Council (SILC) is a non-profit organization dedicated to promoting Independent Living for people with disabilities throughout the state.

Transition Alliance of South Carolina provides interagency teams resources to serve young adults with disabilities who are transitioning from high school to adult-life.

U.S. Department of Labor Disability Resources The federal government website for comprehensive information about disability-related programs, services, policies, laws and regulations.

Vocational Rehabilitation (VR) Department prepares and assists eligible
South Carolinians with disabilities to achieve
and maintain competitive employment.

VR's Disability Determination Services (DDS) unit processes Social Security Disability Insurance claims as well as Supplemental Security Income claims for the Social Security Administration (SSA).

Financial Aid

Children's Rehabilitative Services (CRS) provides financial assistance to families of children under age 18 with one or more chronic illnesses and disabling conditions to pay for medical services, supplies, equipment, and prescription medications.

Community Choices Waiver provides assistance to individuals who want to remain in the community, but who require the level of care necessary at a nursing facility.

Community Supports Waiver serves people with intellectual disability or related disabilities in their home and/or community and offers opportunities for self-directed services.

DHEC Financial Help for Your Child with Special Healthcare Needs provides some financial assistance to help children with special health care needs, including payment for medical services, supplies, equipment, and prescription medications.

DHEC Services for Children with Special Health Care Needs provides information and resources to receive certain services.

GrantWatch- Disability Grants information about available government and foundation grants.

Head and Spinal Cord Injury (HASCI) Waiver recipients receive Medicaid-funded services and supports in their homes and other community settings instead of in a hospital, nursing facility, or institution.

SCDDSN Funding for Specialized TBI/SCI Post-Acute Rehabilitation pays for medical rehabilitation for uninsured or underinsured people with TBI and/or SCI in inpatient/outpatient TBI/SCI rehabilitation programs.

South Carolina Thrive provides innovative and efficient access to quality-of-life resources such as food, security, healthcare resources, and financial wellness.

Supplemental Nutrition Assistance Program (SNAP) offers aid to eligible lowincome families and individuals to ensure these families are able to obtain a nutritious diet.

The Intellectual Disability and Related Disabilities (ID/RD) Waiver provides assistance for individuals with intellectual or related disabilities to receive necessary services.

Healthcare

Medicare is a federal health insurance program for retirees age 65 or older and people with disabilities.

Medicaid provides health coverage to eligible low-income adults, children, pregnant women, elderly adults, and people with disabilities.

BabyNet is South Carolina's interagency early intervention system for infants and toddlers under three years of age with developmental delays, or who have conditions associated with developmental delays.

Community Long Term Care (CLTC) offers programs to help individuals who want to live at home, need assistance with their care, and are financially eligible for Medicaid.

Healthy Connections is South Carolina's Medicaid program. It is a medical assistance program that helps pay for some or all medical bills for many people who cannot afford medical care and provides a variety of programs.

Medicare Rights Center is a national, nonprofit consumer service organization that works to ensure access to affordable health care for older adults and people with disabilities through counseling and advocacy, educational programs and public policy initiatives.

National Health Law Program includes detailed information about federal health policy, especially Medicaid and Medicare.

South Carolina Drug Card is a free statewide prescription assistance program that offers free drug cards to all South Carolina residents.

Special Formula Program provides nutritional preparations recommended by licensed dieticians to children and youth with selected medical conditions who require nutritional supplements for adequate growth and development.

The Free Medical Clinic provides quality health care, at no cost, to uninsured residents of the community who cannot pay for such services.

Legal Advocacy

Disability Rights South Carolina works to improve laws, regulations, policies, or practices to prevent abuse or neglect of individuals with disabilities to gain greater independence and cull inclusion in the community and the workplace.

Protection and Advocacy for People with Disabilities, Inc. promotes the mission of protecting the rights of people with disabilities in South Carolina by enabling induvial to advocate for themselves, speaking on their behalf when needed, and by promoting policies and services which respect their choices.

Self Advocates Becoming Empowered (SABE) is the United States' national self-advocacy organization that works to ensure that people with disabilities are treated as equals and are given the same decision-making opportunities.

South Carolina Bar Pro Bono Program provides professional legal services with no or reduced fees.

South Carolina Legal Aid provides free legal advice or legal representation for eligible individuals who cannot afford legal services.

South Carolina Legal Services (SCLS) provides free legal assistance in a wide variety of civil (non-criminal) legal matters to eligible low-income residents of South Carolina.

Treatment and Rehabilitation

Encompass Health Rehabilitation Hospital of Columbia provides neurological rehabilitation for brain injuries, with customized treatment plans to addresses each client's specific needs and goals.

Health Medical University of South Carolina (MUSC) Rehabilitation Hospital combines clinical collaboration and advanced technologies to provide personalized care to help their clients regain independence after a life changing illness or injury.

Inpatient Brain Injury Program of Roger C. Peace Hospital (RCPH) provides rehabilitation to individuals with brain injuries of all levels of severity.

Roger C. Peace Outpatient Brain Injury and Young Stroke Program is the only program of its kind in South Carolina and maintains specialty accreditation for brain injury, stroke, and vocational programs by the Commission for Accreditation of Rehabilitation Facilities (CARF).

Roper Rehabilitation Hospital's Brain Injury Specialty Program provides comprehensive, specialized care to clients recovering from brain injury in both inpatient and outpatient settings.

Non-Profit Resources

Able SC is an organization built on the central concept of self-empowerment. It's a consumer-controlled, community-based, cross-disability nonprofit that provides an array of independent living services.

AccessAbility South Carolina promotes the full integration of people with disabilities in their communities by empowering the to realize their full potential.
